The committee approved Dr. Glenn Marvin's proposal, Effect of parasitic trombiculid mites (*Hannemania dunlop*) on locomotor performance in a semi-aquatic plethodontid salamander (*Desmognathus concolor*) to be conducted in his research on January 26, 2017.
